GENERAL SERVICE CONFERENCE 2022 TOPICS

CONFERENCE FINANCE COMMITTEE

TOPIC #001/2022 (REFER ATTACHMENTS A AND B)

Pursuant to: NOTES FROM FINANCE COMMITTEE REPORT - (Conference 2021)

"Funds over and above our budgeted operating expenses and our prudent reserve will be moved into a project fund to carry out projects and Conference meeting advisory actions".

This Topic proposes that projects and advisory actions requiring funding be prioritized by the Conference as to the immediacy of action required.

Groups, Districts, Areas, and individual Members be given the opportunity to contribute to a project/advisory action if additional funding is needed to expedite action.

A transparent mechanism be set up to give feedback to the fellowship.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

- 1. Many projects/advisory actions agreed to at Conference are not completed due to insufficient funds.
- 2. Immediacy of the need for any given project is delayed or not achieved.
- 3. Groups, Districts, Areas, and individual Members will be more likely to directly fund projects considered of value and immediacy, example: digital media under National PI.
- 4. Groups, Districts, Areas, and individual Members will have the opportunity to be directly involved in supporting projects/advisory actions that are considered of importance and of immediate need to them and the fellowship. (See attachment B)
- 5. Gives members a sense of direct ownership/involvement in a project/advisory action.
- 6. Provides an opportunity for the fellowship to have an advisory project/advisory acted upon expediently

DO YOU HAVE A SUGGESTED SOLUTION?

- 1. Conference prioritise advisory actions/projects requiring funding, in terms of immediacy
- 2. GSB advise Areas, Districts and Groups of funding for a project and the required funding short fall of that project, giving Areas, Districts, Groups, and individuals Members the opportunity to allocate funds to a specific project (See attachment A).
- 3. As projects are approved by Conference, GSB will create a transparent mechanism to show how they are funded.
- 4. After 2 years, if there are still insufficient funds, funds will be returned to operating expenses or other advisory actions/projects still requiring further funding as determined by the GSB

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

- 1. Advisory actions/projects based on" better carrying the message" will be achieved.
- 2. Advisory actions/projects will be achieved in a more expedient timeframe.
- 3. In the case of PI, advisory actions/projects will cover a broader base of entry/contact for newcomers, for example: all forms of digital media would be used and funded.
- 4. Members become stakeholders in advisory actions/projects, potentially creating more interest in service, which will better serve the still suffering alcoholic.
- 5. Since unused funding is returned to operating expenses or other advisory actions/projects after 2 years, funds may be reallocated.

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION?

The costs would be the additional time spent in allocating funds within the budget

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

"In all our affairs" is an online meeting. Since no Virtual Area has been created, no District or Area has been asked about this topic.

This topic has been developed from members across Australia attending this meeting.

Some members are past and current Delegates, ex Trustees and the meeting Steering Committee.

TOPIC #009/2022

To remove the No Discount status of more than 17% of the items on the literature price list, Items that are priced between \$0.01 and \$40.00, we have to pay freight, and because members expect to pay the official price, we sell these items at a loss.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

1.I am my districts current literature officer, and have held this position several times since 2004. So I understand our costs.

We receive a 23.5% discount on the bulk of the items we buy but freight takes a little over 50% of that on average, plus we need to supply tax invoice receipt books, if the items were only the very low cost items it would not be a concern, but almost all Public Information items up to \$35.00, some pamphlets, a \$40 sign, a \$15.00 comic book, are not discounted

DO YOU HAVE A SUGGESTED SOLUTION?

- 1. Give us the discount on all items over \$0.10
- 2. For the GSO to send non discounted items separately, and for them to pay the freight
- 3. For the GSO to charge flat rate freight, so we all pay at the same rate per kilo regardless of location

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

Increased availability of recovery resources. Because of increased viability of CSO literature funds increases our ability to hold stock, any profit belongs to the district, which regularly donates to Area and the GSO.no profit= reduced ability to donate.

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION?

Probably not huge, but not knowing how much non discounted literature is sold by the GSO, I am not in a position to guess

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

Was presented to the N Q D of AA district meeting on the 9th of May 2022, and received approval,

Was presented to the Area Assembly of the Area A NER area Round Up on the 11th of June 2022

And also received approval there.

CONFERENCE REPORT CHARTER & SERVICE MANUAL COMMITTEE

TOPIC #002/2022 (REFER ATTACHMENT)

Provide more clarity and expand on Section four – the District and District Committee Member - in the Australian General Service Manual, Ninth Edition. Unlike Section 5 of the Service Manual which provides a lot of information about the Area, and suggestions on how to set up and run an Area Assembly and who can vote etc, the literature does not provide as much clarity for conducting a District meeting or who makes up a District committee. It is suggested that Section Four of the Manual be updated to provide groups with more guidance on what a District is and how to conduct a District meeting. Information such as the scope of a District Committee could be helpful (which is clear and concise for an Area in the Manual, but not for a District).

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

- 1. There has been confusion over who has the right to vote at our local District Meeting, and the service literature does not provide clear suggestions about this. We are aware our District is autonomous, but we believe the Service Manual could be updated to further assist groups and Districts. There has been confusion around a District 'committee' and a District 'Meeting'. The group handbook states: "In many cases district committees, composed of all the GSR's in a given district, serve as a filter to the Area Assembly." (Page 41, The Australian AA Group Handbook). Should the wording be changed district meeting? This is just an example of where some of the confusion lies.
- 2. There is no clarity in the Service Manual around who sits on a District Committee and how they are elected, such as there is for the Area.

DO YOU HAVE A SUGGESTED SOLUTION?

- 1. We ask the General Service Conference to consider updating Section Four in the Australian Service Manual, and Guideline GL-05. In the Manual things to update could include how to conduct a District meeting or set up a District committee.
- 2. This update could include clear guidance on who votes in a District meeting, and an explanation of the importance of the GSR at District meetings.
- 3. Clarify what a District Committee role is e.g., to provide assistance to groups and Public Information in the District. Provide a clearer definition of a District meeting versus a District committee in our Australian AA Group Handbook.

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

- 1. A better understanding of district meeting procedures, particularly voting procedures
- 2. Importance of the Group will be further understood by its members to assure proper functioning of the structure of AA.
- 3. An increase in participation of GSR'S at District and Area Assemblies strengthens Unity

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION?

Nil costs. Any updates could be included in future reprints or editions of the Guidelines, Australian AA Group Handbook. The new edition of the Australian General Service Manual comes out in binder form – saving groups and members on having to buy or print the entire Manual, they can just print Section Four and replace it in their current Manual binder.

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

Home group endorsed the Topic. Discussed at our local District meeting (what was outcome?) in March and discussed at Area Assembly in May (provide outcome).

CONFERENCE TREATMENT FACILITIES & ACCESSIBILITY COMMITTEE

TOPIC:#003/2022

A meeting currently exists on the first Sunday of every month that provides an Auslan Interpreter (as well as Closed Captions on Zoom) for the Deaf and Hard of Hearing Alcoholic Community in Australia. We are requesting a broad Australia-wide campaign be mobilised to raise awareness that this meeting is available.

Every Deaf and Hard of Hearing Person in Australia needs be aware that this meeting exists. We are seeking help from AA groups, Area Assemblies, and the General Service Conference to raise awareness that AA welcomes and will support the Deaf/HOH if they wish to investigate a 12-step solution to alcoholism. In addition, closed captions for the meeting also aid many older, sober members with age-related hearing loss.

A core group (2-5 members) of the Deaf and Hard of Hearing are attending regularly, after 5 months from our local word-of-mouth campaign.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

- 1. No 12 Step meeting or any 12 Step Support has consistently been available in Australia for Deaf and Hard of Hearing Alcoholics. We are unaware of any treatment facilities with this capacity.
- 2. Members of PNP group have personal experience in the Auslan community. Discussions at the Group Conscious led to initial efforts to take action.
- 3. Auslan (Australian Sign Language) is unique to Australia. Deaf and Hard of Hearing Alcoholics in Australia are not able to attend online Zoom meetings that might be available in other countries as they do not speak AUSLAN. So, we seek an Australian solution for Auslan speaking alcoholics.

4. Our current experience (and subsequent positive results) make it clear that the enormity of this issue, is beyond our groups capacity to move it forward. If a weekly meeting could be established, many might benefit.

DO YOU HAVE A SUGGESTED SOLUTION?

- 1. Inform AA working committees and groups that a consistent hybrid AA meeting now exists in Auslan. Ask that they contribute ideas that include the D/HOH within their areas of expertise. These ideas can be passed back to a working committee.
- 2. Create and publicise a TTY Line * for potential D/HOH members to communicate and obtain information about AA. This would be the Deaf equivalent of a phone call to the local AA office.
- 3. Implement an awareness campaign throughout AA's Public Information Committees.
- 4. Produce a targeted online advertising campaign for the Deaf /HOH Community. Communicate to this segment through social media, blogs, community boards, Facebook pages and at recreational activities frequented by the Deaf/HOH community. These campaigns could convey our message with more photographs and fewer words.

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

- 1. If the Deaf and Hard of Hearing don't know about us, they will never have the opportunity to explore AA and recovery through the 12 Steps.
- 2. The advent of Zoom and hybrid meetings presents an opportunity for D/HOH alcoholics to create their own meetings and AA network throughout the country. After some members learn the Steps and Traditions, they will be able to work with others in a more positive and effective way than any hearing person. We can't comprehend their needs and roadblocks. We don't have their experience.

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION?

The current cost to Progress Not Perfection to pay for an interpreter for one hour is currently \$284.00.

The yearly cost for supplying a monthly Auslan Interpreter is \$3408.00.

Cost for TTY dedicated Help Line: UnknownCost for online campaign:

The AA Facebook campaign ICD costs \$550.00 per month.

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

PNP members are dedicated to continuing this program. The concerns within our group relate to sustained funding of the project.

Area are supportive and have offered to form a working committee dedicated to helping PNP.

Board Members with exposure to our Deaf members at the Melbourne Convention in 2022 are encouraging.

*A TTY device consists of a keyboard and display screen, with the telephone handset placed on top of the TTY or a direct phone line connected to the TTY, This enables the Deaf to communicate by telephone.)

TOPIC #004/2-22 (REFER ATTACHMENTS A, B, C AND D)

To have conference approved literature of a less formal, easier to read and us type that improves a Treatment Facility's patient's engagement with Alcoholics Anonymous after they have left the facility and also if possible, whilst they are in their facility.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

Many years of experience in AA service involved in Treatment Facilities service has made apparent to those doing so that there is a weakness these detainees and patients must overcome to maintain momentum with their recoveries. That being the gap between inside their facility and AA on the outside (And to a certain extent how much they can engage with AA whilst inside their facility too). So many patients and detainees are keen but quickly succumb to the outside world when they don't have a plan of their own involving our program and fellowship in easy to comprehend suggestive terms.

DO YOU HAVE A SUGGESTED SOLUTION?

Our Area's Correctional Facilities team have put together a simple suite of documents on the theme 'Bridging the Gap'. The documents are not as formal in appearance as all directions or literature from Correctional or Treatment facilities and contain useful pragmatic suggestions.

CONFERENCE LITERATURE COMMITTEE

TOPIC #008/2022

To add wording to any relevant pamphlets and the service manual to better reflect or clarify that when there is no local CSO then an AA District could become the responsible entity for that role and could be supported by local group contributions.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

There is often confusion as to how local is defined when groups are distributing their contributions. Quite often some see a CSO located long distances from them in another AA Area as their "local office while their group in fact belongs to an AA District in their own AA Area. The financial outcome for Districts is that funds for their local PI work / phone service / web page finishes up in a CSO which has no connection to the AA Districts or relevant groups in that locality.

DO YOU HAVE A SUGGESTED SOLUTION?

If the wording better explained the term local and how a district can take the place of a CSO when no CSO resides within an AA Area it would allow members of these groups to make well informed decisions in regards to the distribution of group contributions.

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

This would allow for the opportunity for Districts to be better funded and better placed to carry out their primary purpose as regards to PI work within the district. Enabling districts to fund PI initiatives to carry the message to the still suffering alcoholic within the local area and also allow for better opportunity for districts in carrying out their full roles in the service structure. Naturally the autonomy of each group would still allow distribution of contributions to be allocated to whoever the group decides.

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION A one cost for printing brochures and changes to the service manual.

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

This topic was raised and discussed initially at District 9 and taken to Area B where it was raised and was voted to be put on hold, however the Area Chair and Area Delegate after more discussion are happy to endorse the topic. District 9 has unanimously voted to put this forward as a topic. It has also been discussed and endorsed by our World Service Delegate.

TOPIC #010/2022

The members of Conference request that the Board investigate and pursue mechanisms by which Australian members (and the worldwide fellowship generally) can have a say in future decisions regarding changes to our key literature.

At present, changes to our most important AA literature - including the Big Book, the 12&12 and the Preamble - can only be approved by the North American General Service Conference. This means that only members from the USA and Canada can have a say. Members in the rest of the world are excluded from the process.

'The final responsibility and the ultimate authority for AA world services should always reside in the collective conscience of our whole fellowship' ...

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

As stated in Concept One (quoted above) the whole fellowship has responsibility and authority for world services. However, members in 178 of the countries in which AA has a presence do not get a vote on proposed changes to our key literature. Members in the USA and Canada have a say, as they elect delegates to the North American General Service Conference – but the rest of us do not.

Given the central, vital role of literature in supporting all three legacies, and the affection and gratitude we feel for our core publications, we believe it's time to allow the whole fellowship to participate in considering and approving any changes.

DO YOU HAVE A SUGGESTED SOLUTION?

There might not be a solution – but this topic seeks to start a process to find one if possible.

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

We would all benefit from an improved sense of participation, inclusion and global unity. Our literature would be truly ours, wherever we live.

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION? Expected to be minimal.

HAVE YOU ASKED YOUR GROUP, DISTRICT OR AREA TO MAKE A DECISION ABOUT THIS TOPIC AND, IF SO, WHAT WAS THE OUTCOME?

Endorsed by my home group, District and Area.

TOPIC #011/2022

That the Conference agree to make the AA Australia Group Handbook freely available to all members as a downloadable PDF.

WHAT IS THE BACKGROUND OR REASON FOR THE TOPIC?

My research efforts for a recent Area Assembly Workshop led me to trying to locate a PDF, downloadable version of the AA Australia Group Handbook. I could not locate one, and yet for groups it serves a very similar function to the AA Australia Service Manual and Guidelines, which are downloadable, cost-free.

DO YOU HAVE A SUGGESTED SOLUTION?

Make the AA Australia Group Handbook available for download, cost-free, alongside the AA Service Manual and Guidelines on asservice.org.au. This would also allow many group, district, area and other service-related websites to also offer it as a download, as they currently do the manual and guidelines.

HOW WILL THE ALCOHOLIC WHO STILL SUFFERS OR THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS BENEFIT FROM THIS SUGGESTION?

Having a strong group service focus does not just lead to our own sobriety, but to that of countless others. It literally fulfils AA's singularity of primary purpose. I am assuming it is in recognition of this fact that the conference has decided to make both the service manual and guidelines as freely available as possible to the fellowship, without cost. It is for this reason that we could also make the group handbook available. Effective examples of altruistic service - i.e. the types that benefit the alcoholic who still suffers - often stem from being involved in an informed, involved, '24/7' group, but to be a part of one takes knowledge and application of the contents of the handbook. Why make this most essential of all group information sources something we have to pay for? Doesn't this literally restrict the carrying of our vital message?

WHAT ARE THE ESTIMATED COSTS OF IMPLEMENTING THIS SUGGESTION?

Minimal to zero, I would imagine. No doubt the handbook exists as a PDF already and any IT implementation costs should not be prohibitive.

(See additional information attached, sent from the GSO to better inform the groups re the history of extended terms).

2. Tradition 9 the long form states rotating Leadership is the best, Concepts XI &XII and multiple sections in the AA General Service Manual support the spirit of Rotation.

DO YOU HAVE A SUGGESTED SOLUTION?

- 1. The GSC instruct the GSB to set a Policy (as above).
- 2. Leave jobs vacant so that they can be filled. A filled position is impossible to fill.
